

**WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS BICYCLE CLUB
AGREEMENT, WAIVER & RELEASE OF RESPONSIBILITY**

I, the undersigned, know that CLUB BICYCLE RIDING is a potentially hazardous activity and I do it out of my own free will and choice. These include, without limitation, physical injury, mental injury, emotional distress, trauma, sickness, illness, death, contact with other participants, equipment failure, inadequate safety equipment, the effects of weather including extreme temperature or conditions, traffic, contact with motor vehicles of all types and descriptions, collision with other riders or fixed objects, the conditions of the road. I am aware of and appreciate all risks. I waive any and all specific notice of the existence of the risks. I realize that WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS RIDES require physical conditioning and I represent that I am in sound medical condition capable of participating in the ride without risk to others or myself. I have no medical impediment, which would endanger others or myself. I understand and agree that a situation may arise during A CLUB RIDE which may be beyond the control of the sponsors, promoters, or organizers. I will be solely responsible for the condition and adequacy of my bicycle, safety gear and riding equipment. I will ride safely within the limits of my own abilities, my equipment, and the riding conditions and in a manner so as not to endanger either others or myself. Knowing these facts and in consideration of my participation in WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS CLUB RIDES and related events. I for myself and anyone acting on my behalf, release, waive, discharge, covenant not to sue and agree to hold WHITE MOUNTAIN VELO/LITTLETON LAND SHARK BICYCLE CLUB sponsors and participating clubs, communities, and organizations; CLUB officials emergency and support personnel, volunteers and their representatives; official, friends of WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS BICYCLE CLUB; and the officers, directors, employees, representatives, agents, and successors of WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS BICYCLE CLUBS, harmless from any and all claims, demands and actions of any and every kind I have, may have, or may hereafter accrue against the released parties directly or indirectly arising out of or relating in any respect to my doing or participating in WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS BICYCLE CLUB RIDES and related events.

My waiver and release of all claims, demands, actions and liability shall include without limitation, any injury, damage or loss to my person or property which may be (a) caused by any act, or failure to act, by persons and entities or (b) sustained by me before, during, or after WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS BICYCLE CLUB and its related events, agree to abide by all WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS BICYCLE CLUB rules and regulations, understand that my name, address, photograph, voice and/or likeness may be used in promotional or advertising materials of or by the WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS BICYCLE CLUB. I consent to such uses and waive any rights or privacy or publicity it may have in connection with those uses. I further agree to indemnify and hold the parties released harmless from any and all losses, damages, claims and expenses, including attorney's fees, arising from or relating in any respect to my participation in WHITE MOUNTAIN VELO/LITTLETON LAND SHARKS BICYCLE CLUB RIDES or related events or my breach of this agreement. If I am a minor, my parent or guardian also is signing on my behalf and we both agree to be bound by the terms of this agreement, waiver, and release.
